- (f) All GLR survey numbers which are classified as B-4 can be used as specified in GLR or as per sanction of Ministry of Defence or competent authority.
- (g) All GLR survey numbers which are classified as B-4(inside notified civil area) can be used as specified in GLR or as per sanction of Ministry of Defence or competent authority.
- (h) All GLR survey numbers which are classified under C land can be used as specified in GLR or as per sanction of Ministry of Defence or competent authority.
- (i) The GLR survey numbers which are classified as "Free hold" land is earmarked for use activities as specified in GLR.
- (j) The GLR survey numbers which are classified as "Private" land is earmarked for use activities, as per the decision of the Board.

The file containing all the concerned papers in r/o above land use plan is placed on the table for perusal and consideration of Board.
