Sir-Madam, Sanitation workers across the country often work in poor working conditions and without proper protection and tools. There is a lack of safety equipment and proper procedures are seldom followed, which puts the lives of thousands of sanitation workers at risk. The Parliament has enacted The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013 for prohibition of manual scavenging and rehabilitation of existing Manual scavengers. In terms of section 10 of the the Cantonment Board act 2006 Every Board shall be deemed to be a municipality under clause (e) of article 243P of the Constitution for the purposes of: (a) receiving grants and allocations or (b) implementing the Central Government schemes of social welfare, public health, hygiene, safety, water supply, sanitation, urban renewal and education. In this regard information on following points may be provided: 1. Name, age and parentage of all the Workers died in the incidence of manual scavenging in last four years. 2. Name of the contractor if the Workers were on roll of any contractor. 3. Whether these workers were extended social security benefits and were enrolled in EPF and ESIC. Details like PF No.\UAN\ESIC No. be provided for all workers. 4. Compensation if any awarded to these Workers. 5. Whether any survey has been carried out to list out insanitary latrines and listing out manual scavengers under Section 11 of The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013, in your jurisdiction. Copy of reports of such surveys including list of such manual scavengers. 6. Details of rehabilitation provided to manual scavengers in terms of Section 16 of The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013. 7. Name and number of persons employed as manual scavengers engaged in hazardous cleaning under Section 2(d) of The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013. 8. Name of the person responsible for the engagement of workers in violation of provisions of the Prohibition of Employment of workers in Manual Scavengers and their Rehabilitation Act 2013. 9. Action taken against officer/officials in terms of Section 8 & 9 of The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013. 10. Details of the trials made against the offenders for offences made under The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013.
